Synopsis

This study aid features an innovative method of content organization. It uses a checklist format to lead students through questions they need to ask to fully evaluate the legal problem they are trying to solve. It also synthesizes the material in a way that most students are unable to do on their own, and assembles the different issues, presenting a clear guide to procedural analysis that students can draw upon when writing their exams. Other study aids provide sample problems, but none offer the systematic approach to problem solving found in this book.

I cannot say enough good things about this book. I have tried other "Acing" books, and have liked them alright, but this one probably saved my Contracts grade. It covers everything a typical 1L class covers, it's short, simple, and has very easy to follow explanations. The checklists in the back are great when preparing for exams. I highly recommend it.

I found this book sort of jammed together sections of jargon and statements. Some parts are OK. I preferred Contract Law for Dummies to be much better and laid out sequentially. It tries to cut to the chase but doesn't. Contract Law for Dummies, E&E on contracts and Emanuel Outline breakdown does a much better job, IMO. This book was short, but not straight to the point and sort of jumbled together. Acing Civ Pro is laid out much better.

This helped me a lot. The best part is the checklist. I received a few days before exam. Revised the checklist to what I thought would be covered. High score. I have since purchased Torts and Criminal. Don't expect to be as good because they have different authors.

This book is an easy read and if you pay attention it tells you exactly how things should be written. If you are taking contracts this book makes things easier. All you have to do is make sure you follow your elements. Smile..
