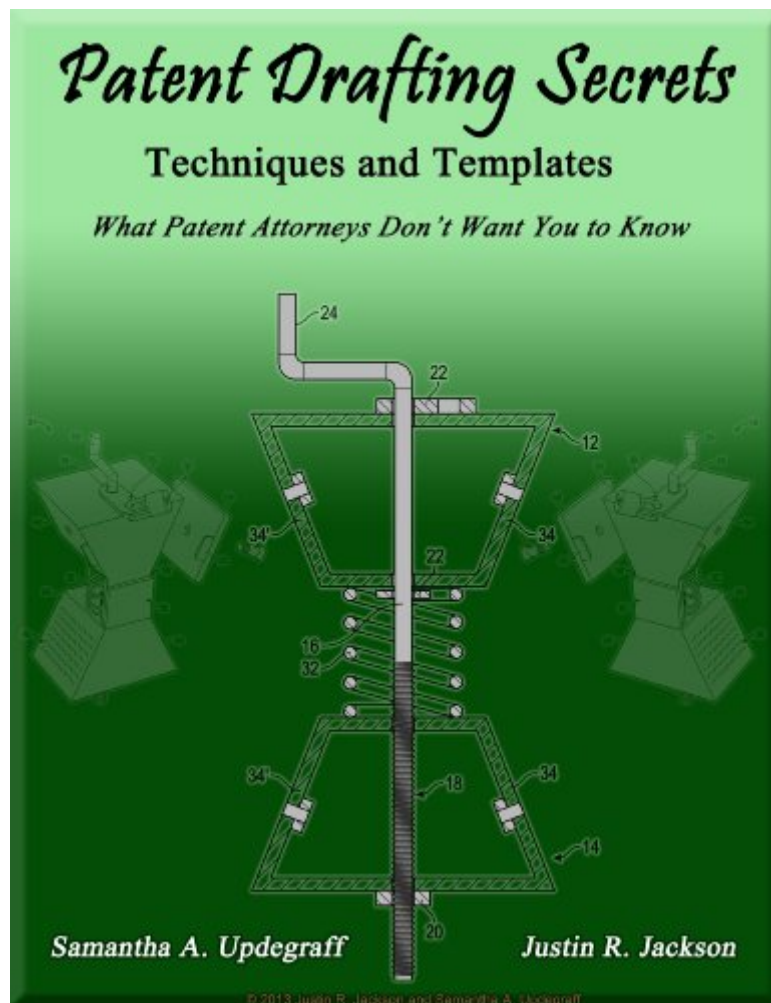

Because the laws and strategies relating to the preparation of the "claims" section of a patent application are rapidly evolving and changing with each new court decision, that small section of the patent application is left for your patent attorney to complete. Typically, a patent attorney will charge anywhere from about \$7,000 to \$10,000 or more to prepare and file a high quality utility patent application for an invention. However, by following the strategies and techniques in this book, you can perform the bulk of the work in preparing a patent application - namely, describing your invention. A competent patent attorney can then review your work and perform the more legalistic aspects of the patenting process. Using the included templates and following the guidelines and suggestions in this book can save you thousands of dollars.
