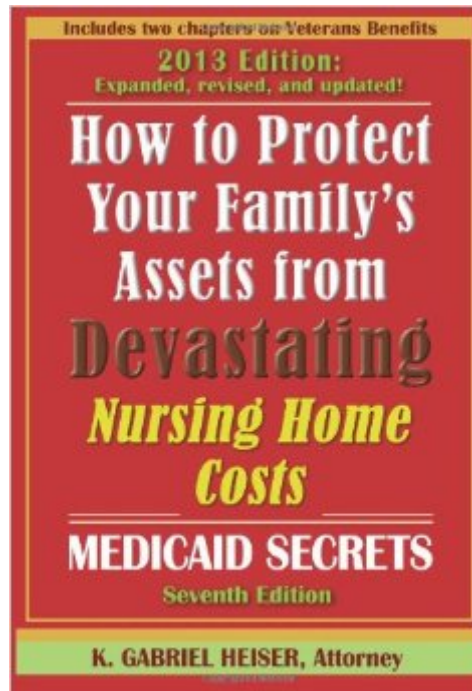

Nonetheless, the book ties together details in a way that certainly isn't blindingly obvious from state and federal Web sites. The punch line, though, is that you need to hire a local attorney.

You may have just saved our lives. The techniques you share in your book are a must-read for anyone with parents approaching retirement age or already retired parents, when nursing home is a part of the equation.

This book contained a lot of good information for a general understanding of Medicaid. Lots of tips on how to protect your assets before becoming Medicaid eligible.
