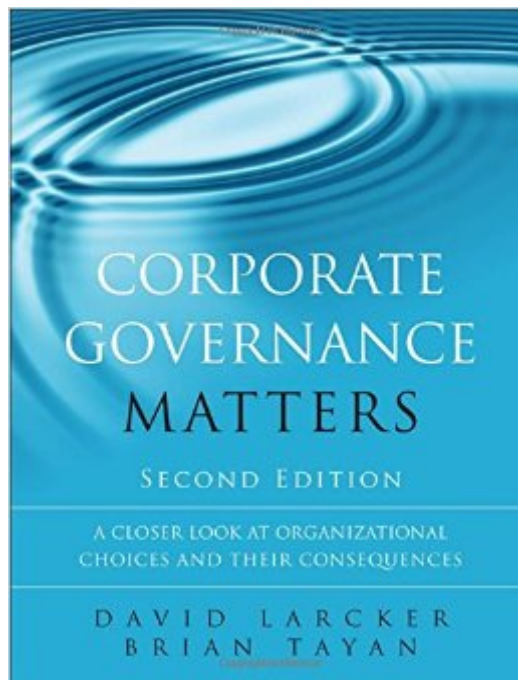

An excellent book and all you really need to get a grasp of the vast amount of material in the field of corporate governance. The book is concise, clear and state-of-the art. David Larcker is a senior scholar in the field of Accounting; he was a Professor at the Wharton School before Stanford. The book draws upon (peer-reviewed) academic studies and distills these into plain English. Speculation is eschewed in favor of sound empirics and common-sense theory.

I continue to look for an affordable book that reflects insight into Corporate Governance. The video

interview of this book's two authors uses the first minutes (I got no further before deep ennui set in) bemoaning a tick box approach (duh) and that they have the answer from empirical studies to how the context is what counts.
