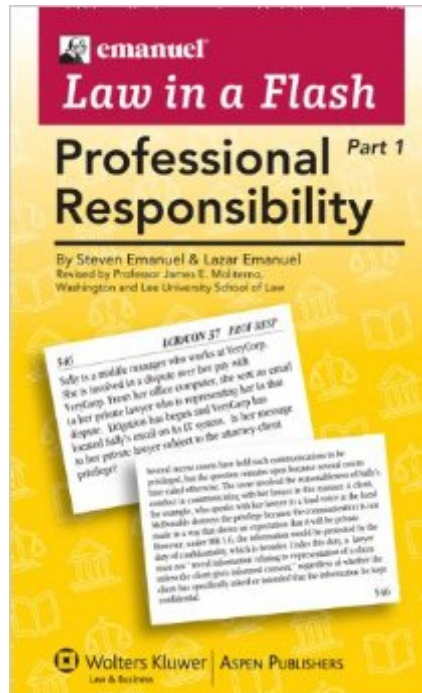

I had not taken a bar exam since I took the Louisiana bar over 20 years ago. I decided to take the MPRE recently and had never taken it before. The cards were extremely helpful. I made a 93 on the test. If you have not taken a bar exam in a long time and need a complete refresher course, I would recommend this learning tool.

These cards were a great study aid while taking the Professional Ethics class this summer and I will continue to study with them until I take the MPRE in November. The fact patterns are funny and engaging. Law in a Flash is a great way to study while walking on a treadmill too.

I don't know how much time you plan on putting into studying for the MPRE, but I put in a fairly good amount. And I'm glad I did. It's more difficult than many people will admit.If you fall into the "I'm just

going to study the day before" camp, I wouldn't recommend this. Honestly, there are so many cards here that I think you really need at least four days for any of it to stick. I personally got so bored with this that I didn't even finish the second deck. It is the definition of thorough. If you can imagine a situation where the Model Rules would be called upon, the authors have probably thought of it before you and written a card for it. So my advice to you is that if you plan on putting in a good two weeks of study for this test and are serious about blowing it out of the water, this would be a good study aid. But if you are merely looking to pass it, there are far less time consuming ways to get the job done. It put me to sleep a few times.

I took the MPRE having only studied with the Barbri free MPRE course. I got a 76, and my state required an 80 to pass. So that sucked. The second time around, all I did was study these flashcards (went through the whole set once, a few cards for concepts I was shakier on the day before to refresh my memory), and that time I got a 113. Soâ |. I'm a fan :)

The brief hypos on these cards helped me learn the Professional Responsibility rules by applying them over and over again. I was able to use small amounts of time for study, and the cumulative result was a great deal of study time and a good score on the MPRE.

This is an exceptional tool in the toolbox for the MPRE and the bar exam. Comprehensive, covering the Model Rules as well as the CJC, you will be able to work through the nearly 1,000 cards and by the end of the two boxes, have a strong feel for the subject matter. Exceptional

In preparation for for the MPRE, I purchased this item and I must say that it is well work the price. The item is very useful as it goes into great detail and covers all of the materials needed for the exam. I did very well on the exam and felt confident when taking it because of this study tool. I would suggest this product for anyone who plans on taking the MPRE in the future or those who may want to learn more about Professional Responsibility.

I've been out of law school for a number of years and practicing law in a single state. Recently, I had to get licensed in a new state and that meant taking the MPRE again. Even in law school I was never one of those students who could get by studying outlines. So I went looking for a flash card set and found these. They were worth every penny. I not only passed the MPRE this time, but got pretty close to a perfect score. These cards made up 90% of my review time, and gave me the

ability to distinguish among the very subtle factual distinctions you find on the MPRE. I would highly recommend that anyone taking the MPRE, or just taking the class in law school, get these cards.
